Expression of Interest

Candidate must register on Ontario One-Key Portal and submit an EOI Application

Invitation to Apply

Based on IRCC Draws candidates will receive an Invitation to apply

OINP Application

Employer must fill out a comprehensive Form. The form along with the job offer is submitted by the candidate in the online application as part of their documentation

On Approval

Once the IRCC approves the Nomination, the Candidate has 14 days to apply for either Work permit or PR

Labour Market Impact Assessment



What is an LMIA

A Labour Market Impact Assessment is a document that an employer in Canada must receive before hiring a foreign worker.



Purpose

A positive LMIA, indicates a need for a temporary foreign worker and that no Canadians or PR of Canada are available to do the job



Eligibility

- Business is active for more than 1-year,
- Full-Time Job Vacancies (30 Hours)
- The business is in good financial standing with no outstanding
- Offer median wage prescribed for the role and region

TYPES OF LMIA

Low Wage

High Wage

- Wage offered is <u>below</u> the provincial <u>median wage.</u>
- Examples: Cooks, Housekeepers,
 Kitchen Helpers

- Wage offered is <u>above or at</u> the provincial <u>median wage</u>.
- Examples: Food Service Attendants, Frontdesk

- One- way Flight Ticket is to paid for
- Providing or identifying suitable housing
- Cost of Housing should not exceed 30% of salary
- Insurance for the period during which candidate is not covered by provincial health coverage

3 Dual Intent

- Both high-wage or low-wage application can be part of dual intent LMIA
- Used to support, both a work permit and an Express entry application.
- Beneficial for a Permanent Residence application
- It helps an applicant obtain 50 CRS points.

LMIA STEPS



Job bank

All employers must register on the Job bank



Job Ad

Job ads should be live on the Job bank for a period of 1 month.



Documentation

- Business License
- CPA Letter <u>or PD7A/</u> Schedule 100 & 125



Application

Online Submission with average approval times of 6 to 8 weeks
